Explanation of Responses:

- The securities awarded are in the form of restricted stock units ("RSUs") issued pursuant to the Issuer's 2014 Stock Option and Incentive Plan. Each RSU represents a contingent right to receive one share of the Issuer's common stock.
- These RSUs were issued pursuant to the reporting person's election to convert a portion of his 2014 performance bonus from cash to equity. The RSUs will vest in their entirety on April 1, 2016. All RSUs that have not vested will automatically terminate if the reporting person's employment is terminated by the Company for cause or the reporting person voluntarily terminates his employment with the Company, subject to certain acceleration provisions set forth in the reporting person's employment agreement.
- These RSUs were granted as part of the Issuer's long term incentive program for executive officers. The RSUs will vest in four (4) equal annual installments beginning on April 1, 2016. All RSUs that have not vested will automatically terminate upon the reporting person's termination of employment with the Issuer and its subsidiaries, subject to certain acceleration provisions set forth in the reporting person's employment agreement.
- Shares acquired as Company matching contributions under the Metabolix, Inc. 401(k) Plan.
