On May 30, 2013, the Company held its Annual Meeting of Stockholders (the "Annual Meeting"). As of April 1, 2013, the record date for the Annual Meeting, 34,365,227 shares were issued, outstanding and entitled to vote. At the Annual Meeting, the Company's stockholders elected Peter N. Kellogg, Celeste Beeks Mastin and Robert L. Van Nostrand to the Company's Board of Directors for three-year terms expiring at the 2016 Annual Meeting of Stockholders, and ratified the selection of PricewaterhouseCoopers LLP as the Company's independent registered public accounting firm for 2013.
